In 622, a standard Muslim Nation was run by the Prophet himself. After his departure, four Caliphs took over the rule, known for their righteousness. This era of government is considered one of the best in Islamic history, second only to the model of governance in Medina. Under the guidance of these righteous caliphs, the Muslim polity transformed into a Muslim Empire. The four caliphs served for thirty years, successfully

Pan Islamism won momentum as a motion to unite Muslims worldwide. After the disintegration of the Ottoman Empire, 5 meetings have been held to unite Muslims worldwide: the Cairo Congress (1926), Congress of Mecca Jerusalem Congress European Muslim Congress (1935), and Interparliamentary Congress of Arab (1938). In 1931, in the course of a assembly in Jerusalem, the organization advanced a established framework that also exists today. The organization presently holds consultative reputation with the United Nations and different UN entities, in addition to observer reputation inside the Organization of Islamic Cooperation (OIC). Its advent become a substantial fulfillment for the Muslim global because it aimed to set up a globally identified Muslim organization. During the Iraq-Iran struggle fare from 1980-1988, the Organization performed a function in finishing the war among the 2 Muslim countries [9].
